INSTRUCTIONS FOR NAME CHANGES

All forms must be typed or clearly printed in ink. The court will not accept forms for filing unless they are accurate, complete, and legible. If you have legal questions about this procedure, or are unable to properly complete the following forms, please seek assistance from a qualified attorney. Laws and rules regarding name changes are found at MCL 711.1 to 711.3 and in MCR 3.613.

CHECKLIST FOR PETITIONER

- ☐ Applicant has been a resident of Grand Traverse County for a minimum of 12 months immediately preceding the filing of the petition.
- ☐ The **Petition to Change Name** (PC51), is completed and signed.
- ☐ An **Addendum to Protected Personal Identifying Information** (MC97a) is completed with name and date of birth for each individual whose name is being changed.
- ☐ **Filing Fee** - \$197.00. The filing fee includes the cost of one certified copy.
- ☐ **Additional Certified Copy of Order to Change Name (Optional)** - \$12.00 per copy.

ADDITIONAL CHECKLIST FOR MINORS

- ☐ **Birth Certificate** – A copy of the original birth certificate of the minor is attached.
- ☐ **Minor's Consent to Name Change** – If the minor is 14 years or older at the time of the hearing, they **must** sign the Petition **or** submit a Minor's Consent to Name Change (PC51b). If the minor is under the age of 14 and able to state a preference, they should sign the Petition.
- ☐ **Non-Custodial Parent** - If the non-custodial parent of a minor for whom name change is sought has not signed the Petition, a hearing will be required. If the address of the non-custodial parent:
 - is **known**, then along with your Petition, a Proof of Service (PC564) indicating that a copy of the Petition for Name Change and Notice of Hearing was provided to the non-custodial parent.
 - is **not known**, and cannot be ascertained after diligent inquiry:
 - ☐ Declaration of Intent to Give Notice by Publication (PC617).
 - ☐ Publication of Notice of Hearing Regarding Petition for Name Change (PC50). **Type or print the name of the non-custodial parent on the Publication form** after the words: "TO ALL INTERESTED PERSONS including."
- ☐ **Child Support Payment History** – If both parents have not signed the Petition and the custodial parent filing the Petition claims that a support order has been entered and the non-custodial parent has failed to substantially comply with the support order for a period of two years or more before the filing of the Petition, then a Child Support Payment History must be obtained from the Friend of the Court and filed along with the Petition.

GENERAL INFORMATION ABOUT NAME CHANGES

Hearings: A hearing will be required if the request is for a minor and both parents have not consented to the name change or if a significant criminal history is disclosed or revealed following a criminal history background check.

Criminal History Report: The Court may use ICHAT or LEIN to determine whether the individual requesting a name change has a criminal record.

Publication: If a hearing (proceeding) is conducted **and** no order for nonpublication or confidential record has been entered, Publication is required pursuant to MCL 711.1(2) and MCR 3.613(B). It is the Petitioner's responsibility, once a hearing date has been provided (unless a Fee Waiver has been granted) to submit the Publication of Notice of Hearing to a newspaper as defined by MCR 2.106(F) for publication in Grand Traverse County. The Publication of Notice of Hearing should be immediately submitted to the Traverse City Record Eagle. A copy of the Affidavit of Publication must be received a minimum of 14 days prior to your scheduled hearing. Failure to timely pay the publication fee may result in cancellation or adjournment of your hearing.

For your convenience, contact information for Grand Traverse County publications is being provided; however, you may utilize any newspaper meeting the requirements under MCR 2.106(F).

Obtaining a New Birth Certificate: If you were born in Michigan and wish to obtain a new birth certificate from the Michigan Vital Records Department showing the new name, you must file an [Application to Correct or Change a Michigan Birth Record](#) (form DCH-0847). The current fee to obtain an amended birth certificate is \$50.00, payable to the State of Michigan. You will be required to send a certified copy of your Order along with the completed form and fee. If you were not born in Michigan, you will need to consult the specific requirements of the state in which you were born.

- A. You must complete form *PC 51* or *PC 51c* to begin a name change proceeding.
