MiChildSupport And MiLogin

In November of 2020, the State of Michigan began using a Single Sign-On feature for all of their services. This means that users only have to remember one username and one password for their various accounts. Users are able to access their Friend of the Court information along with Secretary of State, Department of Natural Resources and many more!

Once you have created a MiLogin account, you will need to click on “Request Access” in the green menu bar below your name. Then select “Michigan Department of Health and Human Services (MDHHS)” and then “MiChildSupport.”
